OVARIAN CANCER RESEARCH ALLIANCE WAS FOUNDED IN 1994 (AS THE OVARIAN CANCER RESEARCH FUND, INC.) AND IS A FULL-SPECTRUM ORGANIZATION FUNDING MEDICAL RESEARCH, ADVOCATING ON BEHALF OF PATIENTS AND PROVIDING SUPPORT AND RESOURCES TO PATIENTS AND THEIR FAMILIES.

OVARIAN CANCER IS THE DEADLIEST OF ALL GYNECOLOGIC CANCERS AND RANKS FIFTH AS THE CAUSE OF CANCER DEATH IN WOMEN. IN 2025, THERE WERE 20,890 NEW CASES OF OVARIAN CANCER AND 12,730 DEATHS FROM THE DISEASE IN THE UNITED STATES. THE ACCOMPLISHMENTS OF OCRA'S PROGRAMS REFLECT OUR COMMITMENT TO THE OVARIAN AND GYNECOLOGIC CANCER COMMUNITIES.

SINCE 1998, OCRA HAS AWARDED 457 GRANTS FOR OVARIAN AND RELATED CANCER

IN 2025, OVARIAN CANCER RESEARCH ALLIANCE (OCRA) PROVIDED COMPREHENSIVE EDUCATION, SUPPORT, AND NAVIGATION SERVICES TO THOUSANDS OF INDIVIDUALS AFFECTED BY OVARIAN AND GYNECOLOGIC CANCERS. OCRA'S PATIENT SUPPORT TEAM RESPONDED TO 4,237 PATIENT AND CAREGIVER CONTACTS THROUGH OUR PATIENT SUPPORT LINE, A 68% INCREASE FROM 2024, PROVIDING EMOTIONAL SUPPORT, INFORMATION, CLINICAL TRIAL GUIDANCE, PEER MENTORING, AND CARE NAVIGATION.

OCRA'S WOMAN TO WOMAN PEER MENTOR PROGRAM CONTINUED TO CONNECT NEWLY DIAGNOSED PATIENTS WITH TRAINED SURVIVOR MENTORS THROUGH 19 ACTIVE SITES NATIONWIDE AND A NATIONAL VIRTUAL MATCHING PROGRAM. SINCE ITS LAUNCH, THE PROGRAM HAS FACILITATED MORE THAN 2,800 MENTOR MATCHES.

OVARIAN CANCER RESEARCH ALLIANCE IS A POWERFUL VOICE ON CAPITOL HILL, IN STATEHOUSES AROUND THE COUNTRY AND WITH FEDERAL AGENCIES FOR EVERYONE TOUCHED BY GYNECOLOGIC CANCER. IN 2025, OCRA ESTABLISHED ITS CENTER FOR PUBLIC POLICY TO EXPAND POLICY EDUCATION, LEGISLATIVE TRACKING, AND ADVOCACY ENGAGEMENT OPPORTUNITIES FOR PATIENTS, CAREGIVERS, AND SUPPORTERS NATIONWIDE. OCRA TRAINED AND MOBILIZED MORE THAN 160 ADVOCATES AND SUPPORTERS TO ENGAGE IN THE POLICYMAKING PROCESS. NEARLY 120 ADVOCATES FROM 35 STATES AND THE DISTRICT OF COLUMBIA PARTICIPATED IN OCRA'S ADVOCACY DAY, CONDUCTING MORE THAN 135 MEETINGS WITH CONGRESSIONAL OFFICES.
